**Tallahassee, Fla.**—The Florida Department of Health issued 19 Emergency Suspension Orders (ESOs) and Emergency Restriction Orders (EROs) during August for serious violations including the commission of crimes, violations of standards of care, drug use, impairment, drug diversion, sexual misconduct or student loan defaults.
