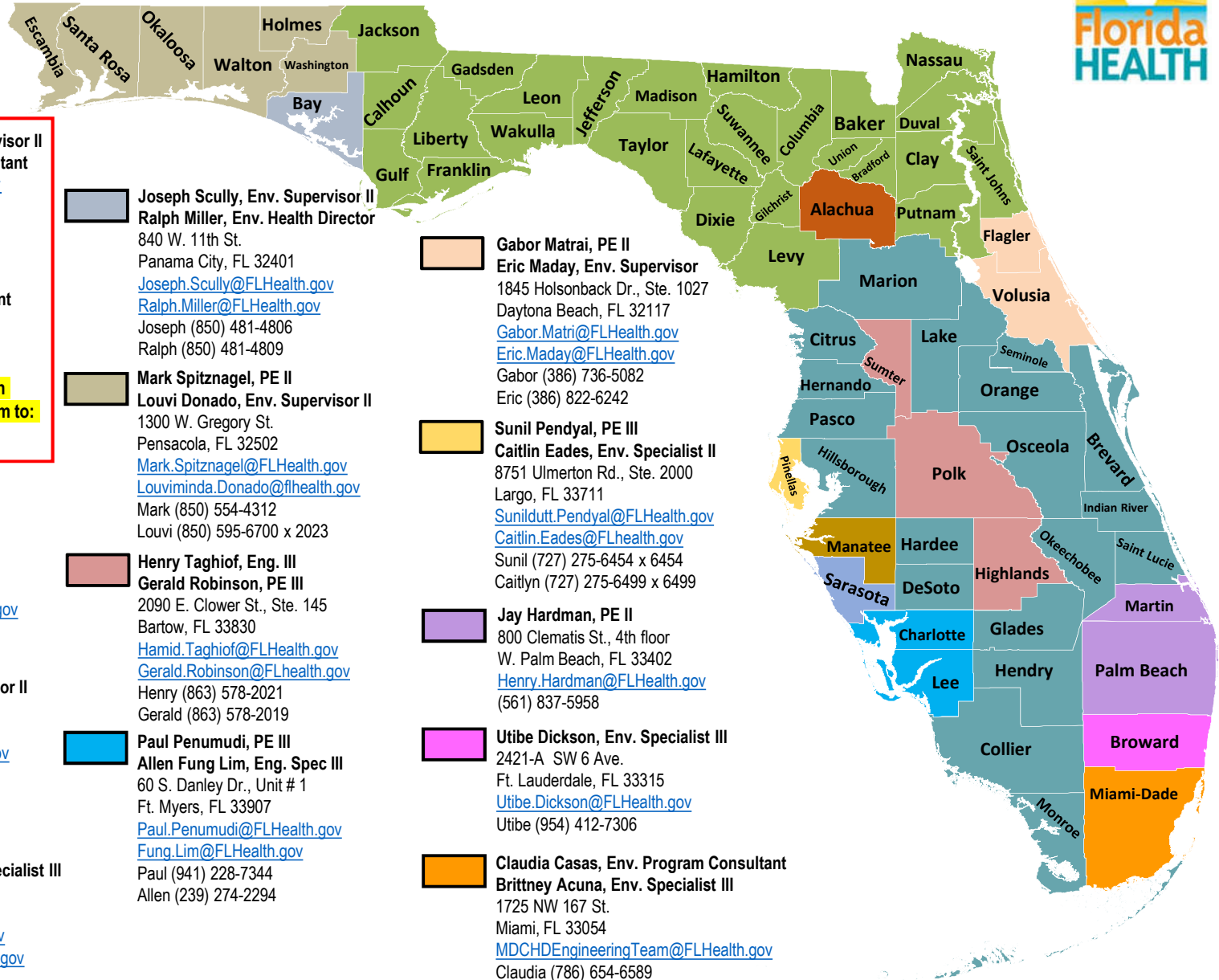


Regional Contact Map For Public Pool Plan Reviews and Construction Inspections
