FINAL ORDER

THIS MATTER came before the Board of Psychology ("Board") pursuant to Section 120.565, Florida Statutes, at a duly-noticed public meeting held on August 16, 2002, in Orlando, Florida, for the purpose of considering the Petition for Declaratory Statement filed by Phyllis K. Jensen ("Petitioner"). Notice of receipt of this petition was published in the Florida Administrative Weekly on August 9, 2002, at Volume 28, Number 32. At the August 16, 2002, hearing on this matter, the Petitioner was not present, nor was she represented by counsel. The Board was represented by Susan B. Bodell, Assistant Attorney General.

Having considered the petition, the Board makes the following findings and conclusions.

FINDINGS OF FACT

1. Section 490.005(1)(c), Florida Statutes, requires that an applicant for licensure as a psychologist in the state of Florida have completed at least 2 years or 4,000 hours of experience in the field of psychology in association with or under the supervision of a licensed psychologist meeting the academic and experience requirements of Chapter 490, Florida Statutes, or the equivalent as determined by the Board.

2. Rule 64B19-11.005(1)(c), Florida Administrative Code, defines "supervisor" as either a licensed Florida psychologist in good standing with the Board, or a doctoral level psychologist licensed in good standing in another state providing supervision for licensure in that state.

3. Petitioner proposes to enter into supervised practice at the American University of the Caribbean Medical School on the island of St. Martin, under the supervision of Lockie Johnson, Ph.D. Petitioner represents that Dr. Johnson is a graduate of Duke University, is licensed to practice psychology in the states of New York and Connecticut, and is licensed by the Netherlands Antilles, which governs the island of St. Martin.

4. Petitioner requests that the Board approve Petitioner's proposed supervised practice.

CONCLUSIONS OF LAW

1. The Board has jurisdiction over this matter pursuant to Section 120.565, Florida Statutes, and Chapter 28-4, Florida Administrative Code.

2. The Petition for Declaratory Statement is denied. The Board requires additional information regarding Lockie Johnson, Ph.D., including a copy of Dr. Johnson's curriculum vitae and independent verification from the states of New York and Connecticut that Dr. Johnson's license to practice psychology in those states is active and in good standing.

3. The Board further requires information regarding the nature of the proposed supervised practice, including a description of the types of professional activities in which the Petitioner will be engaged, as well as a description of the nature of the supervision to be provided by Dr. Johnson.

4. This Order constitutes final agency action and may be appealed by any party pursuant to Section 120.68, Florida Statutes, and Rules 9.110 and 9.190, Florida Rules of Appellate Procedure, by filing a notice of appeal conforming to the requirements of Rule 9.110(d), Florida Rules of Appellate Procedure, both with the appropriate District Court of Appeal, accompanied by the appropriate filing fee, and with the department's clerk of agency proceedings, within thirty (30) days of rendition of this Order.

Description of circumstances:
