1. Discussion: Ordering of Lab Tests by an LDN

- **Rule 64B8-44.007(7), F.A.C., Standards of Practice**

Discussion was had regarding Rule 64B8-44.007(7), F.A.C., Standards of Practice and it was agreed by the Council that the language in this rule should be changed to wording in the effect of "Licensee may order, but not directly collect an analysis of human specimen samples". The record states that Council should not rely on the motions made at the last meeting as it was stated that the Florida Statutes that 64B8-44.007(7) F.A.C. referenced (F.S. 483.035 and F.S. 483.041) were repealed but in fact the statute was moved to F.S. 483.801. The rule change will be reviewed by the Board of Medicine at the next General Business Meeting which is scheduled for December 04, 2020.

MOTION: After Discussion, Ms. Carol Elliott made a motion to approve a rule change by changing the language in Rule 64B8-44.007(7) and sending to the Board of Medicine for final review. The motion was seconded by Dr. Leslene Gordon and carried 5/0.

Question 1- Will the proposed rule amendment have an adverse impact on small business or will the proposed rule amendment be likely to directly or indirectly increase regulatory costs to any entity including government in excess of \$200,000 in the aggregate in Florida within one year after the implantation of the rule? No

INDIVIDUAL CONSIDERATION

1. Carola Marina Vargas Armas (Examination)

Ms. Armas was present.

Ms. Carola Marina Vargas Armas submitted an Application by Examination. A credential evaluation was received from Josef Silny & Associates, INC with a course-by-course evaluation of Ms. Vargas Armas' education. On March 05, 2004, Ms. Vargas Armas was awarded the degree of Physician- Surgeon by the Central University of Venezuela which is the equivalent of the U.S. degree of Doctor of Medicine earned at a regionally accredited institution of higher education in the United States. Ms. Vargas Armas went on to pursue graduate study at Simon Bolivar University in Venezuela from 2005 to 2007 and completed the graduate program in 2007 and was awarded the degree of specialist in Clinical Nutrition on March 20, 2009. This is the equivalent of completion of 39 quarter hours of graduate study in Clinical Nutrition and related subjects at a regionally accredited institution of higher education in the United States. Ms. Vargas Armas has provided her 900-hour forms by Supervisors Josefina Vellegas de Plaza and Gertrudis Baptista, both of Venezuela, with a total of 1,996 hours as well as both supervisor's resume's. Ms. Vargas Armas also holds an active State of Florida Board of Cosmetology License as a Facial Specialist that expires October 31, 2021.

Ms. Carol Elliott made a motion to approve Ms. Armas' application. Ms. Stephanie Petrosky seconded the motion which carried 5/0.

2. Kenia Del Valle Gil (Examination)

Ms. Gil was present.

Ms. Kenia del Valle Gil submitted an Application by Examination. A credential evaluation was received from Josef Silny & Associates, INC with a course-by-course evaluation of Ms. Gil's education. Ms. Gil attended the Central University of Venezuela from 1993-1998 and completed the five-year undergraduate program in 1998. She was awarded the degree of Licentiate in Nutrition and Dietetics on April 29, 1999. This is the equivalent of a Bachelor of Science in Nutrition and Dietetics earned at a regionally accredited institution of higher education in the United States. A 900- hour supervision form was submitted to Council staff reflecting 700 hours of Hospital internship as well as 800 hours of Community Nutrition. A resume' for noted Supervisor Gertrudis Adrianza de Baptista was also submitted.

Ms. Stephanie Petrosky made a motion to approve Ms. Gil's application. Ms. Linda Rex seconded the motion which carried 5/0.

3. Paula Vincent (Examination with Temporary Permit)

Ms. Vincent was present.

Ms. Paula Vincent submitted an Application by Examination with Temporary License. Ms. Vincent graduated from the University of Arkansas, an ACEND accredited university with a Bachelor of Science in Human Environmental Sciences with distinction. Her plan was Food, Human Nutrition and Hospitality with a sub-plan in Dietetics Concentration. Ms. Vincent also submitted a diploma reflecting a Master of Public Health from Florida International University. (No transcripts received). Ms. Vincent has requested that the Council waive the 900 hour required hours in lieu of her experience. Council staff has pulled the Florida Dietician/Nutritionist license verification for supervisor's Mary Thomas and Kelly Schier. Kelly Schier is listed as supervisor on her temporary permit form and will provide supervision if temporary permit is granted. Ms. Vincent has also submitted letters of references by her current supervisor and director at the WIC and Nutrition office in Polk County.

Ms. Carol Elliott made a motion to approve Ms. Vincent's application. Ms. Linda Rex seconded the motion which carried 5/0.

4. Ashley Comparin (Endorsement of Another State License- Delaware)

Ms. Comparin was not present.

Ms. Ashley Comparin submitted an Application by Endorsement of Another State License. Ms. Comparin holds licenses in both Delaware and Pennsylvania, however, has requested that the Council review her application solely by Endorsement of her Delaware license. Ms. Comparin has submitted the laws and rules of both Delaware and Pennsylvania for law to law comparison as well as her CNS certification. Council staff has pulled both Delaware and Pennsylvania license verifications. Her Delaware license is current and will expire on 05/31/2021 and her Pennsylvania license expired on 09/30/2020.

Ms. Stephanie Petrosky made a motion to approve Ms. Comparin's application. Ms. Kelly Jones seconded the motion which carried 5/0.

5. Carol Galati (Endorsement of Another State License- Pennsylvania)

Mr. Galati was not present.

Update: On 10/26/2020 Ms. Carol Galati has requested to withdraw her application as she is retired and was only planning on doing volunteer work. F.S. 468.13 requires that an applicant applying by the method of Endorsement of Another State hold a valid license in that state. She does not wish to renew her Pennsylvania license in according to F.S. 468.13. Ms. Carol Galati submitted an Application by Endorsement of Another State License. Ms. Galati held an active license in Pennsylvania at the time of the submission of her application, however, subsequently her license expired September 30, 2020. Council staff pulled her Pennsylvania license verification at the time of application and as recent as October 21, 2020. Ms. Galati provided the Pennsylvania Laws for law to law comparison and Council staff provided the rules.

6. Grisel Aracelin Ramos Rodriguez (Endorsement of Another State License- Puerto Rico)

Ms. Rodriguez was present.

Ms. Grisel Aracelin Ramos Rodriguez submitted an Application by Endorsement of Another State License. Ms. Rodriguez holds an active state license in Puerto Rico which will expire January 23, 2022. She has submitted the Laws and Rules of Puerto Rico for law to law comparison as well as her license verification. She has also included a letter of good standing in the Spanish language.

Ms. Stephanie Petrosky made a motion to approve Ms. Rodriguez's application. Ms. Linda Rex seconded the motion which carried 5/0.

7. Ana Maria Puente (Endorsement of Another State License- Maryland)

Ms. Puente was present.

Ms. Ana Maria Puente submitted an Application by Endorsement of Another State License. Ms. Puente holds an active license in Maryland which expires October 31, 2022. Council staff pulled the license verification. Ms. Puente submitted the Laws and Rules of Maryland for law to law comparison.

Ms. Stephanie Petrosky made a motion to approve Ms. Puente's application. Ms. Kelly Jones seconded the motion which carried 5/0.

8. Megan Bowman (Endorsement of Another State- Illinois)

Ms. Bowman was present.

Ms. Megan Bowman submitted an Application by Endorsement of Another State License. Ms. Bowman holds an active license in Illinois. Council staff pulled the license verification which expires October 31, 2021. Ms. Bowman submitted the Laws and Rules of Illinois for law to law comparison.

Ms. Carol Elliott made a motion to approve Ms. Bowman's application. Dr. Leslene Gordon seconded the motion which carried 5/0.

9. Michael Farris (Examination with Waiver)

Mr. Farris was present.

Dr. Michael Farris submitted an Application by Examination with Waiver. Dr. Farris earned a Master of Science in Nutrition and Functional Medicine on June 19, 2015 from University of Western States in Portland, Oregon. He also graduated from Maryland University of Integrative Health in Laurel, Maryland with a Doctor of Clinical Nutrition on April 21, 2019. Dr. Ferris submitted his CNS certification along with 900 Hour Forms by Supervisors Laurie Lawson and Elizabeth Lipski. Council staff pulled license verifications for both supervisors. Ms. Lipski holds an active dietician license which expires October 31, 2021 and Ms. Lawson holds an active Osteopathic Medicine license which expires April 30, 2022. Resume's for both supervisors have been submitted.

Ms. Carol Elliott made a motion to approve Mr. Farris' application. Ms. Kelly Jones seconded the motion which carried 5/0.

10. Tiffany Anne Smith (Endorsement of CDR)

Ms. Smith was present.

Update: Ms. Smith was ordered to make a required appearance at the November general business meeting per her conditions given by the Council at the August 06, 2020 general business meeting. Ms. Smith has submitted all documentation requested by Council per her conditions to Council staff in the required timeframe. Ms. Smith was issued Florida license ND9939 on August 11, 2020 with a status of Probation/ Active. Ms. Tiffany Anne Smith previously applied by Endorsement by CDR. Ms. Smith was sent a deficiency letter requesting court documents for criminal history that was acknowledged on her application. On May 1, 2020 the Investigative Services Unit with the Florida Department of Health Bureau of Enforcement notified staff supervisor of a possible unlicensed activity case on Ms. Smith.
