**INDIVIDUAL CONSIDERATION**

**1. Carlos Alberto Monsalve Gutierrez (Examination)**

Mr. Gutierrez was present.

Mr. Gutierrez submitted an application by Examination. Mr. Gutierrez requested a translator to be present. Ms. Saori Yamashita from Links Translation provided translation services for Mr.

Gutierrez. Mr. Gutierrez's education was obtained in Colombia and has provided a credential evaluation as well as 900-hour forms for the Council's review.

Following discussion, Ms. Stephanie Petrosky made a motion to approve Mr. Gutierrez's application. Ms. Carol Elliott seconded the motion which carried 4/0.

## **2. Elaina Galvao (Examination)**

Ms. Galvao was present.

Ms. Elaina Galvao was before the Council for review of her application by Examination. Ms. Galvao is an international applicant and has requested that her additional education/experience used in lieu of the 900-hour required supervised experience pursuant to Rule 64B8-42.002(5), F.A.C.

## **3. Wallace Alex Ribeiro (Examination)**

Mr. Wallace Alex Ribeiro was before the Council for review of his application by Examination. Mr. Ribeiro waived his 90-day requirement for board action pursuant to F.S. 120.60. A credential evaluation was received as well as several 900-hour forms to reflect his documented experience.

Ms. Carol Elliott made a motion to approve Mr. Ribeiro's application. Ms. Kelly Jones seconded the motion which carried 4/0.

## **4. Flavia Velten Rangel Palombini (Examination)**

Ms. Palombini was present.

Ms. Flavia Velten Rangel Palombini submitted an application by Examination. A credential evaluation was received as well as a 900-hour form reflecting her supervised experience. Ms. Palombini also submitted additional documentation for the Council's review.

Ms. Stephanie Petrosky made a motion to require Ms. Palombini's appearance and toll her application until one of the next two meetings to provide additional documentation that is more specific to her 900 hour supervised experience and also to provide documentation showing that her supervisor, Dr. Mendez has training equivalent to a licensed dietitian/nutritionist, as required by Rule 64B8-42.002(3), Florida Administrative Code. Ms. Palombini waived the "deemer" clause pursuant to Section 120.60(1), Florida Statutes. Ms. Palombini requested that her husband translate for her during the meeting and her husband was sworn in to translate. Dr. Leslene Gordon seconded the motion which carried 4/0.

## **5. Sharon Brescia (Examination)**

Ms. Goldsmith previously took the RD exam for licensure purposes in New York and also submitted verification.

## **8. Amber Diane Pawula-Marcin (Examination w/ Waiver)**

Ms. Kelly Jones seconded the motion which carried 4/0.
