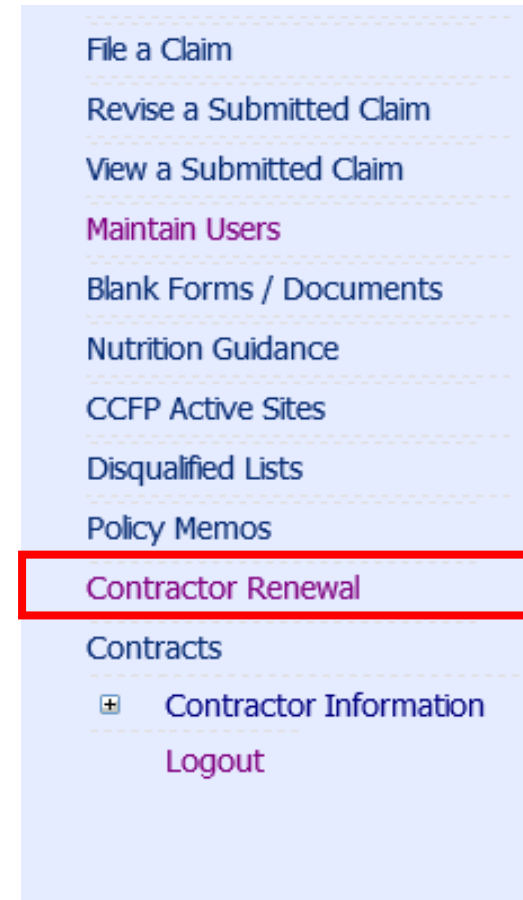


CHECKING THE STATUS OF YOUR RENEWAL
