**SUBJECT:** Kindergarten and Seventh Grade Immunization Status Report  
2021–22 School Year

Section 1003.22(4)(a), Florida Statutes and Florida Administrative Code Rule 64D-3.046(2)(a) requires each student to have a *Florida Certification of Immunization* (DH Form 680) Part A on file in the state immunization registry, the Florida State Health Online Tracking System (SHOTS), prior to entry or attendance in a Florida public or non-public (private) school, indicating they met the immunization requirement for their grade.

Students in kindergarten (KG) through sixth grade must have a Part A (Florida Department of Education [DOE] Code 1), certifying they received four or five doses of diphtheria, tetanus toxoids and acellular pertussis (DTaP) vaccine, four or five doses of inactivated poliovirus vaccine (IPV), two doses of measles, mumps and rubella (MMR) vaccine, three doses of hepatitis B (hep B) vaccine and two doses of varicella (VAR) vaccine (or physician-documented disease history). Students in seventh through twelfth grades must have a Part A (DOE Code 8), certifying they received one dose of Tdap (tetanus toxoid, reduced diphtheria toxoid and acellular pertussis) vaccine in addition to all doses of all vaccines required for KG.

Students without a Part A must have one of the following exemptions from vaccination on file: DH Form 680, Part B (temporary medical exemption [TME]) (DOE Code 2); DH Form 680, Part C (permanent medical exemption [PME]) (DOE Code 3) or *Religious Exemption From Immunization* (DH Form 681) (RE) (DOE Code 4). Exception: Schools may issue a provisional exemption for up to 30 calendar days (30-Day Exemption) for students transferring from a school in another Florida county/school district, entering the juvenile justice system or experiencing homelessness (DOE Codes W, X and Y).

Additionally, schools with a KG or seventh grade are required to submit an annual compliance report to the Florida Department of Health (DOH) indicating the immunization or exemption status of all KG and seventh-grade students at the beginning of the school year. Private schools manually reported aggregate school-level data and non-aggregate student-level data for students without a Part A to the local county health department (CHD). CHDs then reported aggregate school-level and county-level data to DOH's Immunization Section by October 31, 2021. Public schools electronically reported student-level and school-level data to their school district, which in turn electronically reported to the DOE. DOE then reported aggregate school-level and district-level data to the Immunization Section on January 11, 2022.

The public-school data (census) comprised 199,695 KG and 220,110 seventh-grade students enrolled in its 73 public school districts. This included 5,020 KG and 1,960 seventh-grade students in virtual instruction programs who do not come to a district school building for any activities and for whom none of the other immunization status codes (for Data Element 132025) apply, as well as home education and migrant non-enrolled students (Code 0). Because these students are exempt from the school-entry and attendance immunization requirement, they are excluded from this report. Private schools serving only this (exempt) population do not submit an annual compliance report, and those serving exempt and non-exempt students do not include the exempt students in their compliance report.

This report includes data for the remaining 194,675 KG and 218,150 seventh-grade students from 2,361 (KG) and 1,459 (seventh grade) public schools, as well as 29,737 (KG) and 26,357 (seventh grade) students from the reporting 1,686 (KG) and 1,401 (seventh grade) private schools, by immunization and exemption status, by physical county location. To protect the privacy of individual students, data are masked for counties/school districts with fewer than 10 students enrolled in KG or seventh grade.

Whereas we previously listed the non-county-specific public school districts (Florida A&M University [FAMU], Florida Atlantic University [FAU], Florida School for the Deaf and Blind, Florida State University [FSU], Florida Virtual School [FLVS] and University of Florida [UF]) after the county-specific public school districts/counties in our reports, this report incorporates them with the county-specific public school district/county **for totals by physical county location**. For example, the FAU lab school district is made up of two schools. The data for their Palm Beach County school are combined with the data for Palm Beach County, and the data for their St. Lucie County school are combined with the data for St. Lucie County. FLVS is the exception, as it serves students statewide.

### **Results—Kindergarten:**

**Statewide**, 91.7% (range=81.1 [Gadsden] to 98.9% [Taylor]) of KG students were reported as having a Part A. Students with exemptions accounted for 8.2% of the KG population—TME (3.8%) (range=0.0% [Taylor] to 18.1% [Gadsden]), PME (0.4%) (range=0.0% [20 counties] to 1.5% [Miami-Dade]), RE (3.5%) (range=0.4% [Taylor] to 10.2% [Sarasota]) and 30-Day Exemptions (0.4%) (range=0.0% [29 counties and FLVS] to 7.0% [Indian River]). The remaining 372 students (0.2%) were out of compliance. Of the 67 Florida counties, 18 (26.9%) achieved or exceeded the 95% coverage goal and nine (13.4%) had fewer than 90% (Table 1).

**In public schools**, 91.9% (range= 78.5 [Gadsden] to 98.9% [Holmes]) of KG students were reported as having a Part A. The percentage of students with an exemption was 8.1%—TME (4.1%) (range=0.0% [Taylor] to 20.6% [Gadsden]), PME (0.4%) (range=0.0% [21 counties] to 1.9% [Miami-Dade]), RE (3.0%) (range=0.4% [Taylor] to 9.8% [FLVS]) and 30-Day Exemptions (0.5%) (range=0.0% [29 counties and FLVS] to 7.6% [Washington]). Not including FLVS, Sarasota had the highest percentage of KG students with an RE, with 7.5%. The remaining 67 students (0.0%) were out of compliance (Table 2).

**In private schools**, 90.1% (range= 0.0% [Glades] to 100% [9 counties]) of KG students were reported as having a Part A. A total of 8.8% had an exemption—TME (1.8%) (range=0.0% [24 counties] to 100% [Glades]), PME (0.3%) (range=0.0% [44 counties] to 2.1% [Martin]), RE (6.7%) (range=0.0% [11 counties] to 27.1% [Sarasota]) and 30-Day Exemptions (0.0%) (range=0.0% [58 counties] to 0.4% [Escambia, Lee]). The remaining 305 students (1.0%) were out of compliance. Three CHDs (Baker, Calhoun and Union) reported having no private schools with KG students in their counties (Table 3).

Thirty-two counties (50.0%) had fewer than 90% of KG private-school students with a Part A compared to nine counties (13.4%) of KG public-school students. Forty-four counties (68.8%) had 5% or more of

KG private-school students with an RE, 20 of which had 10% or more compared to two counties (3.0% [Flagler, 5.5%; Sarasota, 7.5%]) and FLVS (9.8%) of KG public-school students. Thirty-three counties (49.3%) and FLVS (6.0%) had 3% or more of KG public-school students with a TME compared to seven counties (10.9%) of private-school students. The highest 30-Day Exemption rate of KG public-school students was 7.6% (Indian River) compared to 0.4% (Escambia and Lee) in private schools (Tables 2 and 3).

**Compared to the 2020–21 school year**, statewide enrollment increased by 8.4% from 207,026 to 224,412 students, which is 1.7% less than pre-pandemic (2019–20) enrollment. The percentage of students with a Part A decreased from 93.3% to 91.7%, which is the lowest since the 2010–11 school year (91.3%). The percentage of students with a TME increased from 3.0% to 3.8%, which is the highest since the 2012–13 school year (4.0%). The percentage of students with an RE increased from 2.7% to 3.5%, which is the highest ever. The percentage of students with a PME and 30-Day Exemption are again at 0.4%. The COVID-19 pandemic likely played a significant role in the continued decrease of KG students with a Part A and continued increase of students with a TME, as well as the increase of students with an RE (Table 4).

### **Results—Seventh Grade:**

**Statewide**, 94.3% (range=84.3 [Duval] to 99.4 [Calhoun]) of seventh-grade students were reported as having a Part A. Students with exemptions accounted for 5.4% of the seventh-grade population—TME (2.0%) (range=0.0% [11 counties] to 6.4% [Osceola]), PME (0.3%) (range=0.0% [28 counties] to 1.8% [Miami-Dade]), RE (2.4%) (range=0.0% [Jefferson and Liberty] to 6.8% [FLVS]) and 30-Day Exemptions (0.7%) (range=0.0% [33 counties and FLVS] to 11.4% [Duval]). Not including FLVS, Sarasota had the highest percentage of seventh-grade students with an RE, with 6.7%. The remaining 648 students (0.3%) were out of compliance. Of the 67 counties, 49 (73.1%) achieved or exceeded the 95% coverage goal and one (Duval; 84.3%) had fewer than 90% (Table 5).

**In public schools**, 94.6% (range= 82.5% [Duval] to 99.4% [Calhoun]) of seventh-grade students were reported as having a Part A. The percentage of students with an exemption was 5.4%—TME (2.1%) (range=0.0% [12 counties] to 6.9% [Osceola]), PME (0.4%) (range=0.0% [30 counties] to 2.0% [Miami-Dade]), RE (2.1%) (range=0.0% [Hamilton, Jefferson and Liberty] to 6.8% [FLVS]) and 30-Day exemptions (0.8%) (range=0.0% [36 counties and FLVS] to 13.6% [Duval]). Not including FLVS, Sarasota had the highest percentage of seventh-grade students with an RE, with 5.5%. The remaining 41 students (0.0%) were out of compliance (Table 6).

**In private schools**, 91.9% (range= 40.0% [Glades] to 100% [9 counties]) of seventh-grade students were reported as having a Part A. A total of 5.8% had an exemption—TME (0.8%) (range=0.0% [35 counties] to 40.0% [Glades]), PME (0.2%) (range=0.0% [42 counties] to 1.4% [Indian River, Nassau]) and RE (4.7%) (range=0.0% [14 counties] to 20.0% [Jackson]). The remaining 607 students (2.3%) were out of compliance. Two CHDs (Calhoun and Union) reported having no private schools with seventh-grade students in their counties (Table 7).

Twenty-seven counties (41.5%) had fewer than 90% of seventh-grade private-school students with a Part A compared to only one county (1.5% [Duval; 82.5%]) of public-school students. Twenty-nine counties (44.6%) had 5% or more of seventh-grade private-school students with an RE, 10 of which had 10% or more, compared to one county (1.5% [Sarasota, 5.5%]) and FLVS [6.8%]) of seventh-grade public school students (Tables 6 and 7).

**Compared to the 2020–21 school year**, statewide enrollment increased by 0.4% from 243,633 to 244,507 students. The percentage of students with a Part A decreased from 94.5% to 94.3%, which is the lowest since the 2009–10 school year (93.4%). The percentage of students with a TME decreased from 2.6% to 2.0%; however, this is still significantly higher (0.7%) than pre-pandemic (2019–20) RE

rates. The percentage of students with a PME decreased from 0.4% to 0.3%. The percentage of students with an RE increased from 2.1% to 2.4%, which is the highest ever. The percentage of students with a 30-Day Exemption increased from 0.1% to 0.7%, which is the highest since the 2014–15 school year (0.9%). The COVID-19 pandemic likely played a significant role in the continued decrease of KG students with a Part A and continued increase of students with a TME and RE, as well as the increase of students with a 30-Day Exemption (Table 8).

**Discussion:**

The findings in this report are subject to at least five limitations. First, comparability is limited because of varying data collection methods between public and private schools. Second, representativeness might be negatively affected because of data collection methods that missed some private schools. Third, public school coverage rates may be positively or negatively affected because data include six non-county-specific public school districts. Fourth, 30-Day Exemptions may be significantly overestimated for KG and seventh grade in Duval County public schools (due to several schools reporting between 50 and 66.7 percent of its students as having a 30-Day Exemption), thereby affecting county and statewide 30-Day Exemption rates for those grades. Fifth, out of compliance rates may be significantly underestimated for KG and seventh grade in Duval County public schools (due to the possible overestimation of 30-Day Exemptions), thereby affecting county and statewide out of compliance rates for those grades.

CHD immunization staff should continue to partner with local schools, school districts, managed care organizations and private health care providers to ensure that schools and school districts comply with Florida’s immunization requirements for school entry.

Schools and school districts should understand:

- They may directly access a student’s DH Form 680 or 681 in Florida SHOTS by submitting a completed *Authorized School and Licensed or Registered Child Care Facility User Agreement for Access to Florida SHOTS* (DH Form 2115) to the Immunization Section. DH Form 680 directly accessed by the student’s school is considered certified in writing and signed by the Florida SHOTS private provider. DH Form 2115 is available online at [flshotsusers.com/schools-child-care-centers](http://flshotsusers.com/schools-child-care-centers).
- Parents or guardians may decline Florida SHOTS participation for their child by submitting a completed *Florida SHOTS Notification and Opt Out Form* (DH Form 1478) to the Immunization Section. If declined, the student’s DH Form 680 or 681 must be on file at the school. DH Form 1478 is available online at [flshotsusers.com/opt-out](http://flshotsusers.com/opt-out).
- Children entering a Florida public or private school for the first time or transferring to another school in the same county/school district do not qualify for a 30-Day Exemption.
- Students who have not met the immunization requirement and do not have an exemption should not attend school until compliance is met. Section 1003.22(7) indicates “The parents of any child admitted to or in attendance at a Florida public or private school, grades prekindergarten through 12, are responsible for assuring that the child is in compliance with the provisions of this section.”
- When reporting student immunization status (via Data Element 132025 [public] or DH Form 684 [private]) in the fall, assign “no data entered” [public] or “out of compliance” [private] for those children who have no DH Form 680 or 681 on file. Do not assign Code 0 [public] or 30-Day Exemption [public and private].
