Important Information

VFC Update-Calibration Vendors

As of January 1, 2018, it is mandatory to have a data logger as your backup thermometer. Please note that your backup data logger does not have to be the LogTag brand. Refer to Florida SHOTS for a list of data loggers that meet Florida's requirements for continuous temperature monitoring and documentation, http://flshotsusers.com/resources/temperature-data-loggers.

January 1, 2018 also marks the date the federal VFC program will require the use of data loggers, the Immunization Section will no longer support calibration costs for your state-supplied LogTags. You will be responsible for calibration costs and technical support related to your state-supplied LogTags.

Please note that the Florida Department of Health, Immunization Section cannot endorse or recommend specific products or brands. Below is a list of vendors who calibrate data loggers.

Use the table below as a guide to assist you with finding a vendor to calibrate your state-supplied LogTag. The vendor list is not all-inclusive; prices may change and prices may not include shipping costs. The information compiled in the table below reflect one point in time and is meant to assist you with finding a vendor for calibration services.
