Introduction

This is the annual review report for the 2017-2022 Citrus Community Health Improvement Plan (CHIP). The activities and collaborative efforts of the Florida Department of Health in Citrus County and community partners will be reflected within the report. This document will serve as a progress review of the strategies that were developed and the activities that have been implemented. While the CHIP is a community-driven and collectively owned health improvement plan, the Florida Department of Health in Citrus County (DOH-Citrus) is charged with providing administrative support, tracking and collecting data, and preparing the annual review report.

Overview of CHIP and Annual Review Meeting

DOH-Citrus, with the help of WellFlorida, Inc. prepared a Community Health Needs Assessment (CHNA) in 2016. The document was received and approved by DOH-Citrus in January 2016. On February 24, 2016, DOH-Citrus held an initial CHIP meeting with the Citrus Health Improvement Partnership (CHIP Partnership). The purpose of the meeting was to introduce partners to the CHNA findings and the CHIP process as a blueprint for identifying resources and opportunities to improve the health of our community. Shortly after that initial meeting, four subcommittees were created to address the findings of the CHNA and develop the 2017-2022 CHIP. In October 2016, another subcommittee was added to include the Florida Healthy Babies Initiative to address infant mortality.

The CHIP Partnership continued to meet on a monthly basis while the subcommittees met on their own to develop their goals, strategies and objectives using action plans that identified steps, resources, responsibilities and timeframes. These action plans helped to develop the 2017-2022 CHIP, which was approved by the CHIP Partnership on October 13, 2017. The CHIP Partnership reviewed the plan progress and approved the 2018 Annual Progress Report on February 7, 2019 with minor revisions.

In 2019, the CHIP Partnership continued to meet; however, with previous members no longer attending and new members joining, no further action was taken on the preceding goals, strategies and objectives. Also, no changes were made in 2019 to the 2017-2022 CHIP, so the CHIP Partnership made 2019 the last year of this CHIP. The CHIP Partnership completed an annual review on February 6, 2020, where the group discussed accomplishments and areas for improvement.

In 2019, the CHIP Partnership continued to meet; however, with previous members no longer attending and new members joining, no further action was taken on the preceding goals, strategies and objectives.

How Targets Were Monitored

At regularly scheduled CHIP Partnership meetings, updates and reports from subcommittee were a standard agenda item; however, due to the lack of clear objectives, subcommittees had no updates to provide at the CHIP Partnership meetings. Instead, information was shared regarding the progress each community partner was making towards goals that aligned with the CHIP. These updates had more to do with individual agency initiatives rather than the objectives identified in the CHIP.

Revisions

With much consideration in the lack of attainable objectives, new members and many updates from the 2018 CHNA, the CHIP Partnership chose not to revise the plan and instead made 2019 the last year of the plan.

Accomplishments

Within the past 2.5 years, more than 500 Baby Boxes and safe sleep items and education were distributed to Citrus Families at no cost. Because of the subcommittee's commitment to gaining provider/community support and feedback, the Baby Box program presented at the National Association of County and City Health Officials (NACCHO) annual conference in 2018. According to FLHealthCHARTS, the rate of Citrus County infant deaths from unintentional suffocation and strangulation per 1,000 live births decreased from 1.9 (2016) to 1.0 (2018).
Why This Accomplishment is Important for Our Community		
Baby boxes, and the safe sleep education that is provided with them, are credited for helping achieve low infant mortality rates around the world. Through this initiative, more than 500 Baby Boxes and high-quality online parenting courses from health care experts were provided to Citrus families who wouldn't have been able to afford them otherwise.

Why This Accomplishment is Important for Our Community		
Over the next 20 years in Florida, obesity is expected to contribute to millions of cases of preventable chronic diseases such as type 2 diabetes, heart disease and cancer, costing an estimated \$34 billion. According to FLHealthCHARTS, 40.6% of Citrus County adults were overweight in 2016, a percentage that is well above the state percentage of 35.8. Providing easy to understand nutrition education is important in combating the rising rates of obesity and preventing chronic disease in Citrus County, as well as help children and adults make consistent, informed choices about healthy eating and active living.		

Conclusion

The CHIP serves as a roadmap for a continuous health improvement process for the local public health system by providing a framework for the chosen strategic issue areas. It is not intended to be an exhaustive and static document. We will evaluate progress on an ongoing basis through quarterly CHIP implementation reports and quarterly discussion by community partners. We will conduct annual reviews and revisions based on input from partners and create CHIP annual reports by February of each year. The CHIP will continue to change and evolve over time as new information and insight emerge at the local, state and national levels.

By working together, we can have a significant impact on the community's health by improving where we live, work and play. These efforts will allow us to realize the vision of being one of the top 10 healthiest counties in the State of Florida as measured by Robert Wood Johnson.
