### **Executive Summary**

Public Health Accreditation Board (PHAB) 5.2.4.A: The health department must monitor, and revise as needed, the strategies in the community health improvement plan in collaboration with broad participation from stakeholders and partners.


This Community Health Improvement Plan (CHIP) Annual Progress Report provides a unified vision and framework for action for the Seminole County Residents. It serves as the roadmap to protect, promote and improve the health of Floridians in Seminole County. As part of the performance management system, the CHIP review cycle takes place all year round with quarterly reviews and evaluations on the status of strategic priorities, goals, objectives and activities. Progress towards achieving goals and objectives is continuously monitored by the Healthy Seminole Collaborative members through their established subcommittees and the Florida Department of Health (DOH-Seminole) Performance Management (PM) Council. In addition, multiple partners from various community organizations participate in the review and finalization of the Annual Progress Report.

To ensure the CHIP is routinely monitored, every quarter DOH-Seminole hosts a Healthy Seminole Collaborative meeting to provide an opportunity for subcommittees to provide updates on progress made towards accomplishment of assigned objectives and activities. Each subcommittee has two cochairs who lead the subcommittees and two DOH-Seminole liaisons who provide support to the cochairs. Progress is captured on the Activities Tracking Progress Report excel spreadsheet which is available to all Health Seminole Collaborative members.



By the end of 2020, 38% of combined CHIP objectives and activities (n=53) were completed, 49% were on track, 11% required a decision to be made and 2% were not on track or not completed as depicted in the pie chart below. The Healthy Seminole community improvement planning efforts have resulted in several important accomplishments in each of the three priority areas (see 2020 Accomplishments). These accomplishments have improved public health in Seminole County as well as enhanced collaboration among community partners.





### 2020 Accomplishments

Through the dedicated work of community partners, the Healthy Seminole Collaborative was able to achieve great outcomes in the past year despite challenges encountered due to the COVID-19 pandemic. One major accomplishment was Seminole County's improvement in the County Health Rankings from the Robert Wood Johnson Foundation. In 2019, Seminole County ranked 4th in both Health Factors and Health Outcomes. In 2020, Seminole County is ranked 3rd out of 67 counties in Florida for Health Outcomes and 2nd for Health Factors. Published online at countyhealthrankings.org, the Robert Wood Johnson county health rankings help counties understand what influences the health and longevity of residents. The rankings look at a variety of measures that affect the future health of communities, such as high school graduation rates, access to healthy foods, rates of smoking, obesity and teen births.

- CHIC program is ongoing and food vouchers have been provided.

#### Progress in 2020

PHAB 5.3.3.A.1: Progress is evidenced by completing defined steps to reach a target, by completing objectives, or by addressing priorities and implementing activities.

In 2020, progress on this objective was delayed due to the COVID-19 pandemic. However, the Health Equity Advisory Board (HEAB) members made progress on established activities as described in the table below.

Activity HE 1.1.1.1: By July 31, 2020, the Healthy Seminole Health Equity Subcommittee will reestablish an inclusive membership of stakeholders from six in 2019 to at least ten community partner organizations for the Health Equity Advisory Board (HEAB).

<u>Progress Made</u>: The HEAB membership is now comprised of 18 organizations including city and county government leaders, healthcare providers, educational professionals and other community service providers.

Activity HE 1.1.1.2: By August 31, 2020, the HEAB will identify at least three disparate groups (Men, Racial/Ethnic, Age, LGBTQ+, etc.) as the target populations for the community health events.

<u>Progress Made</u>: Three priority populations (*Male, Hispanic* and *Black*) were identified to address gender, ethnicity and race disparities respectively.

Activity HE 1.1.1.3: By July 31, 2021, the HEAB will identify Culturally and Linguistically Appropriate Services (CLAS) providers to participate and resources to distribute at the community health events.

<u>Progress Made</u>: Progress toward completion of this activity has been delayed due to the COVID-19 pandemic. However, a Cultural Competency training, provided by DOH-Seminole's Office of Health Promotion and Education, was presented at the November's HEAB meeting. The training aims to start a conversation around cultural competency and provides attendees with additional tools (trainings, assessments, etc.) for further learning and understanding. Members are currently tasked to identify organizations that provide services that are in alignment with identified priority populations and chronic diseases. In addition, a survey was sent to identify current HEAB members who are CLAS providers. Survey results are anticipated to be available by first quarter of 2021.

Activity HE 1.1.1.4: By July 31, 2020, the HEAB will identify a minimum of five chronic health conditions impacting the three identified disparate groups.

<u>Progress Made</u>: Five chronic diseases (*Cardiac, Respiratory, Diabetes, Cancer* and *Infant Mortality,* included as a chronic condition in the community) affecting identified priority populations were selected.

### ADDITIONAL ACTIVITIES ACCOMPLISHED IN HEALTH EQUITY

HEAB members are committed to support the goal to improve access to care for identified Seminole County residents who are less likely to receive quality and affordable services. Additional activities conducted in partnership with different organizations are listed below:

- ✓ Addressing Male Population On Sunday, January 12th, Alicia Burke, Health Educator and Congregational Wellness Coordinator, attended New Bethel AME Church in Sanford for their annual Men's Day Celebration. The theme was "Faith in the Messiah is the basis of membership in God's new Kingdom". Information on community workshops and health resources including Diabetes Prevention and Self-Management Education Programs were presented to the program attendees. Additionally, the health resource table in the fellowship hall of the church was set up with Men's Health resources and other services offered by DOH-Seminole was shared with the congregation.
- ✓ Addressing Respiratory diseases (COVID-19) Seminole County Emergency Management and the Florida Department of Health in Seminole County in partnership with True Health began hosting Pop-Up Community Test Sites for COVID-19 on Tuesday, April 21<sup>st</sup>. The Apostolic Church-Jesus Christ was the first location to provide the tests from 10am through 2pm with a total of 239 tests given.
- ✓ Addressing Cultural Competency related to Cancer Disease The Health Council of East Central Florida in partnership with The East Central Cancer Control Collaborative released its annual Cultural Competency Report in relation to their three cancer priorities (Cervix (HPV), Lung, and Colorectum). Identified disparities – populations at risk for Seminole county where found for two of their cancer priorities: Black men and women as well as Hispanic men and women for colorectum cancer and Hispanic women for lung cancer.
- ✓ Addressing Cardiac diseases On Saturday, February 8<sup>th</sup>, for the *Pink Goes Red for Heart Health* event here at the health department from 12:30 p.m. 3:30 p.m. This free event is hosted



- by Alpha Kappa Alpha Sorority, Incorporated- Kappa Sigma Omega Chapter of Sanford and community partners
- ✓ Addressing Respiratory disease (COVID-19) to Hispanic population- Starting Saturday, may 9<sup>th</sup>, 2020 a series of Pop-up test sites at Seminole County churches on Saturdays available to Hispanic communities which are experiencing a disparate number of COVID-19 cases in Seminole County, and others who visit the sites. These test sites are made possible through collaboration with The American Muslim Clinic, Bueno Pharmacy and Seminole County Government.

<u>Progress Made</u>: Per monthly Seminole County Overdose Reports produced by the Special Investigations Unit at the Seminole County Sheriff's Office there were 83 opioid related overdose deaths in Seminole County in 2019.

Progress Made: Youth Leadership Council (YLC) to combat opioid use was led by No Limit Health Education organization. The YLC's priority population is high school age students. The YLC is working to create a social media campaign, including a video, planning a virtual conference and presenting to the Sheriff's Office on combatting opioid use within the youth population. The Council will meet once a month, starting December 8, 2020 from 6:00 PM-7:30 PM. Volunteers from the Behavioral Health subcommittee will serve as advisory council for the youth.



Activity BH 1.1.2.4: By June 30, 2023, the Seminole County Sheriff's Office, in partnership with community providers and the judicial system, will initiate a voluntary opioid diversion program as an alternative to incarceration.

<u>Progress Made</u>: An initial meeting with all involved partners, including the Seminole County Sheriff's Office and the judiciary, was held on March 12, 2020. Follow up meetings were stalled due to the COVID-19 pandemic.

- ✓ DOH-Seminole, in partnership with the Seminole County Sheriff's Office (SCSO) and AdventHealth, was awarded a \$500,000 Implementing Overdose Prevention Strategies at the Local Level (IOPSLL) grant to combat the overdose epidemic in Seminole County. Over the course of the next eighteen months, DOH-Seminole's Community Integrated Mobile Health Services (CIMHS) team will work in partnership with the SCSO and AdventHealth to provide community paramedicine and substance abuse therapy overlay services to augment SCSO's Seminole Collaborative Opioid Response Effort (SCORE) services.
- ✓ Yoga 4 Change, Virtual Yoga and Meditation Classes from AdventHealth are offered on Mondays from 10-11 to bring accessible yoga and meditation to individuals in recovery, individuals who are incarcerated, military veterans, and youth.
- ✓ True Health expanded the use of telehealth to include behavioral health.

In 2020, due to the COVID-19 pandemic, progress toward completion of this objective was stalled due to school closures and safety regulations. The program utilizes external delivery partners as well as volunteer drivers to safely transport perishable and nonperishable food items directly to those in need in a contact-free manner. The target populations for this program are seniors, homebound individuals, individuals with a disability, veterans, and those in the high-risk group for contracting coronavirus.
- ✓ Promote Physical Activity The City of Casselberry in partnership with Florida Recreation & Park Association and Walk Florida are encouraging residents to join the Walk Florida Program where a group of participants will attempt to "walk" the state of Florida (2,000,000 steps) over a period of four weeks. Participants enrolled with the City of Casselberry group, receive a pedometer and have a contact person from the city to report the steps.
