I. Welcome and Roll Call – Maggie Dilger, Florida Department of Health

The meeting was called to order at 10:05 a.m. Roll was taken, and a quorum was not established. Representative Jenna Persons-Mulicka was introduced as the newest member appointed to the council.

- III. Bright Expectations Navigation David Blodgett, Florida Department of Health

David Blodgett with the Florida Department of Health reviewed the Bright Expectations website and

discussed ideas for garnering more visits to the pages. Buttons will be added to the main page to direct visitors, and Google analytics will be reviewed over the next quarter and compared to past reports to see how the buttons affected visitor traffic.

IV. Google Analytics Overview – Jessica Day, Florida Department of Health

Jessica Day with the Department provided an overview of the Google Analytics quarterly data and clarified data variables with the council.

 V. Orlando Family Magazine Advertisement – Tara Cockman, Florida Department of Health Tara Cockman with the Department shared the Bright Expectations advertisement in the August 2023 issue of Orlando Family Magazine and mentioned future advertisement opportunities with the publication.

VI. Website Resources Review – Council Members

Kristine Benson updated the group that hypothyroidism should not be added to the website as there are not enough resources or support groups. She reminded the group that the focus of the site is to link families with resources that provide support after receiving diagnosis of a developmental disability.

Kiersten Finchum explained that Landau-Kleffner Syndrome causes epileptic seizures and should be mentioned within the Epilepsy condition tab.

Maggie Dilger with the Department updated the council that a link had been removed from the Bright Expectations website. She explained all sites have to be a non-profit, and the removed link was a vendor site: <u>https://www.bluesprigautism.com/florida-autism-center/</u>. The site was for the Florida Autism Center, and it perhaps, at one time, linked to their support group.
