2. State Rare Disease Advisory Council (RDAC) Panel Discussion

Each state discussed it's RDAC's composition and compared differences in funding and structure noting advantages and disadvantages. There was discussion on creating, funding, and distributing surveys, and how data is being used. Collaborative efforts with research institutions, hospitals, trade associations, and advocacy groups has helped achieve the goals of each RDAC. <u>Project ECHO</u>, a learning model providing training and mentorship to fill gaps in specialty care, was mentioned as a success in Minnesota.

Each RDAC committed to continue working together and sharing ideas to increase awareness and resources for the rare disease community.
