A quorum was present. The meeting was called to order at 10:05 a.m. Board members received all pertinent meeting materials. Board members participated via conference call and could actively and equally participate in the discussion.

I. Meeting Minute Approval

Dr. Armstrong called for a vote on the prior meeting minutes. Dr. Nowakowski made the motion to approve the April 6, 2017 minutes. Dr. Decker seconded the motion. Total votes for approval: (Total members voting: 10) Affirmative: 10, Negative: 0, Recusal: 0.

II. Introductions and Meeting Overview

Dr. Armstrong provided an overview of the meeting agenda and introduced Dr. Houghten, the newest BRAC member. Dr. Armstrong also welcomed the representatives from the Live Like Bella Childhood Cancer Foundation.

III. Discussion of FY 2017-2018 Live Like Bella Initiative Funding Opportunity Announcement

Initial planning focused on the type of funding mechanisms and research priorities that should be included in the Funding Opportunity Announcement.

The BRAC proposed three types of grants: (1) Multicenter clinical trials for up to \$900,000, (2) Basic Science grants for up to \$250,000, and (3) Bridge grants for up to \$100,000. Dr. Armstrong called for a vote on these proposed grant types. Dr. Decker made the motion for a vote. Dr. Nowakowski seconded the motion. Total votes for approval: (Total members voting: 10) Affirmative: 10, Negative: 0, Recusal: 0.

The BRAC discussed possible research priorities for this FOA including health disparities, research infrastructure, discovery science, and epidemiological studies. Further discussion is needed to determine exact priorities for this FOA.

Department staff was asked to look into the possibility of allowing the BRAC to use funds from Bankhead-Coley to fund Live Like Bella awards. Staff discussed this issue with the Budget Director for Community Health Promotion, and were told that this would not be allowable. It is not allowable because the General Appropriation Act (GAA) listed the specific funding allocated for each of these research programs and the two cannot be combined.
