At Patient STEMI Center Activation Time



<u>Date Range:</u>	1/1/2013 12:00:00 AM to 12/31/2013 12:00:00 AM
<u>Purpose</u>	The purpose of this report is to analyze an EMSTARS time interval that represents the amount of time it takes to initiate a STEMI center activation after arriving at the patient .
<u>Definitions</u>	At Patient STEMI Center Activation Time – Refers to the time difference from the time the unit arrives at the patient to the time a STEMI center activation alert is given.
<u>Formulas</u>	At Patient STEMI Center Activation Time = (The First Procedure Performed Date for Procedures Equal to STEMI Center Activation – Arrived at Patient Date Time)
<u>Filter</u>	Due to the fact that this report has customizable filter options, the filters applied to this report are a direct reflection of the input controls selected at the time this report was generated. Any pre-applied exclusions are represented in the 'Exclusions' section below.
<u>Exclusions</u>	At Patient STEMI Center Activation Times not between 0 – 2 Hours

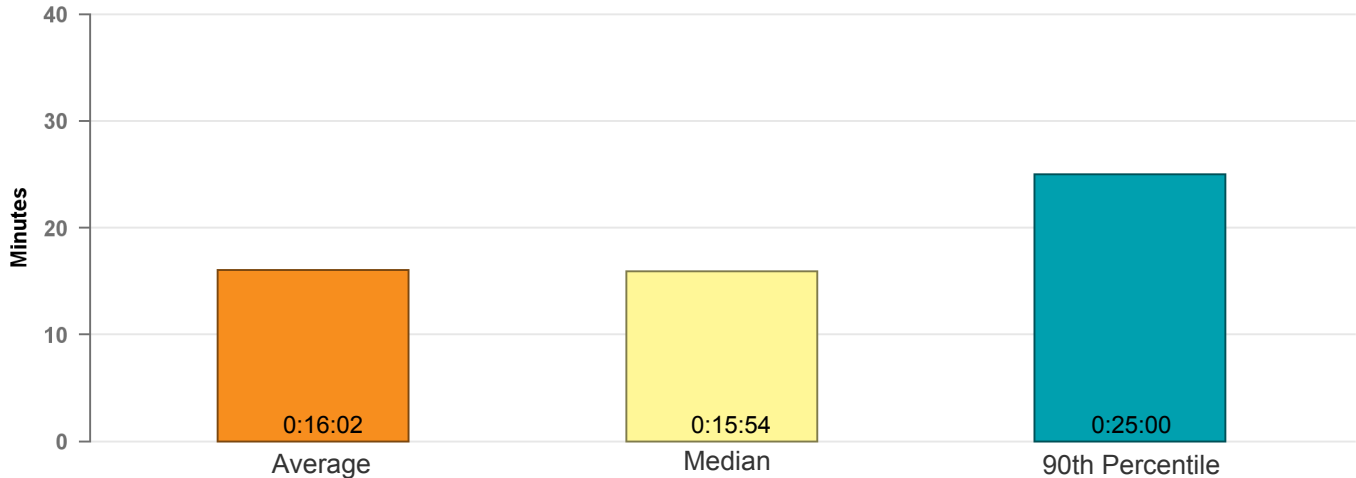


At Patient STEMI Center Activation Time
